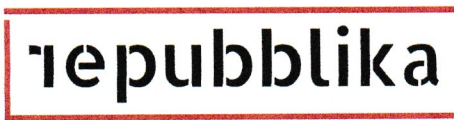

Dear Mr. Baojie,

Repubblika calls your attention to your obligations, as Deputy Chairman of the Board of the company Enemalta plc, to protect the interests of the Maltese people who are a shareholder of this company.

We are shocked at the news that the company, which you and your colleagues are leading, paid 10.3 million euros to purchase a company that only eighteen days before, had been sold at 2.9 million euros. The company, which belongs to all the Maltese people, and that you and your colleagues are managing in our name, paid more than triple the original amount in the space of barely three weeks.

We are shocked by the business deal that was concluded by the company you are leading, with 17 Black, owned by Yorgen Fenech, who is accused of masterminding the assassination of Daphne Caruana Galizia, by means of which the latter company earned 4.6 million euros through the money we pay for our electricity bills.

We remind you that according to the law, you are personally liable if you do not lead the Enemalta plc company in a correct manner.

We expect you to take this scandalous news very seriously, inform your shareholders about what has happened, do all that is necessary to ensure that you recuperate the company's money that was badly spent, and fulfil your obligations.
